

RESOLUTION

Chinle Chapter of the Colorado Cactus and Succulent Society

GRANT \$12,000 TO THE CHINLE CACTUS AND SUCCULENT SOCIETY,
DISSOLVE THE CHINLE CHAPTER
OF THE COLORADO CACTUS AND SUCCULENT SOCIETY
AND

PROMOTE COOPERATION AND COORDINATION BETWEEN THE CHINLE CACTUS AND SUCCULENT SOCIETY AND THE COLORADO CACTUS AND SUCCULENT SOCIETY.

WHEREAS, A number of communication and coordination issues caused largely by the substantial distance separating the West Slope from the Front Range have diminished opportunities for effective participation by the Chinle Chapter in the Front Range activities of the Colorado Cactus and Succulent Society.

WHEREAS. The level of Interest and participation in the Front Range activities of the Colorado Cactus and Succulent Society by members of the Chinle Chapter of the Colorado Cactus and Succulent Society has steadily eroded in recent years.

WHEREAS, The newly formed Chinle Cactus and Succulent Society has elected officers and adopted by-laws that are consistent with those of the Chinle Chapter of the Colorado Cactus and Succulent Society, and

WHEREAS, The purpose of the Chinle Cactus and Succulent Society is to promote knowledge, enjoyment, cultivation, and conservation of cacti and other succulent plants among its members, other individuals and organizations throughout the area; and

WHEREAS. The membership of the Chinle Chapter of the Colorado Cactus and Succulent Society have elected to support the Chinle Cactus and Succulent Society; and

WHEREAS, NOW THEREFORE, THE BOARD OF DIRECTORS OF THE CHINLE CHAPTER OF THE COLORADO CACTUS AND SUCCULENT SOCIETY FINDS, that:

- The benefits of continued affiliation as a Chapter of the Colorado Cactus and Succulent Society are outweighed by the complexities associated with coordination, communication, funding and other aspects of maintaining a geographically diverse Statewide organization.
- Substantial distance, time and communication factors have proven to be major impediments to successfully maintaining an efficient and effective statewide organization.
- An independent, stand-alone, Chinle Cactus And Succulent Society will be better able to focus its efforts on responding to member needs as well as promoting knowledge, enjoyment, cultivation, and conservation of cacti and other succulent plants among its members, other individuals and organizations throughout west-central Colorado.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CHINLE CHAPTER OF THE COLORADO CACTUS AND SUCCULENT SOCIETY, that:

- The Chinle Chapter of the Colorado Cactus and Succulent Society shall grant \$12,000 to the Chinle Cactus and Succulent Society on March 14, 2009 for the purpose of promoting knowledge, enjoyment, cultivation, and conservation of cacti and other succulent plants among its members, other individuals and organizations throughout west-central Colorado.
- The Chinle Chapter of the Colorado Cactus and Succulent Society shall be dissolved on March 16, 2009 and all remaining assets of the Chinle Chapter of the Colorado Cactus and Succulent Society shall be provided to the Colorado Cactus and Succulent Society.
- Cooperation and coordination between the Chinle Cactus and Succulent Society and the Colorado Cactus and Succulent Society shall be promoted.
